If a self-payer living in a CTU dormitory stays alone in a double room, he or she may ask the Service Facilities Administration (the Accommodation Services Department) to change the status of such room into a single room and agree to pay a 50% additional fee over and above the published price list.

**Applicable only to the following categories:**

- a) Students from other than Czech universities; lifelong learning courses;
- b) Persons who have terminated a university programme at a Czech university (effective from the 4th business day; if you are a foreigner, it is effective one month after termination of the university programme);
- c) Applicants for Bachelor's, follow-up and post-graduate study programmes and CTU graduates;
- d) Employees from companies collaborating with the CTU;
- e) Teachers from other universities collaborating with the CTU in Prague;
- f) Students during the **summer break** can stay 2 nights if they are sitting for an examination; it is not necessary for them to submit a certificate issued by the relevant Study Department that the examination was held (see The General Terms of Accommodation, point 18);
- g) Students during **summer break** for a period shorter than 10 days (see The General Terms of Accommodation, point 19);
- h) Students until they can prove (by submitting a student certificate) that they are studying at a Czech university (see the current Accommodation Scenario).

Prices may be adjusted to reflect statutory changes to the VAT rate.
