The price is given in CZK per 1 bed/day including VAT, with minimum residence of 30 continuous calendar days.

If a student residing in a CTU dormitory is staying alone in a double room, they may ask the SFA (economic manager) to designate the room as a single room, with the current price as listed in the valid Price List for Self-payers being raised by 50%.

Pricelist for self-payers apply only for these categories:

- students from-non-Czech higher education institutions; students of Lifelong Learning courses
- residents who have completed their Czech higher education studies (from the 4th working day following studies completion; for people with permanent residence outside of the Czech Republic, by one month from completion of studies at the latest)
- those on the "waiting list" for bachelor's, follow-up or doctoral study and university graduates
- employees of companies co-operating with CTU in Prague
- higher education teachers co-operating with CTU in Prague
- accommodating university students during the summer holidays after a period of 2 nights to try it out with no confirmation of examinations taking place issued by the relevant study department (see the General Terms of Accommodation)
- accommodating students up to the day of physical proof of studies (valid issued confirmation of study) at a Czech higher education institution (see Accommodation Scenario)
